## Section IV – Emergency and First Aid Measures

**Inhalation:** If inhaled, remove to fresh air. If not breathing, give artificial respiration and obtain immediate medical assistance.

**Eye contact**: Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical attention if irritation persists.

**Ingestion:** Immediately call a poison control centre or physician. Do not induce vomiting unless told to do so by a poison control centre or physician. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.

**Skin contact:** Remove contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Consult a poison control centre or physician immediately.

**Additional Information:** Treat symptomatically and supportively. This product contains a pyrethroid. If a small amount is ingested (or if treatment is delayed) oral administration of large amounts of activated charcoal and a cathartic is probably sufficient therapy. If localized paresthesia develops, the site should be thoroughly washed with soap and water. Cold cream can be applied to help diminish the effect. DO NOT INDUCE VOMITING.

### Section V - Fire Fighting Measures

**General Information**: As in any fire, wear a self-contained breathing apparatus in pressure-demand,

MSHA/NIOSH (approved or equivalent), and full protective gear. Vapours may form an explosive mixture with air. Vapours can travel to a source of ignition and flash back. Use water spray to keep fire-exposed containers cool. Containers may explode in the heat of a fire. Vapours may be heavier than air. They can spread along the ground and collect in low

**Handling:** Wash thoroughly after handling. Use with adequate ventilation. Avoid contact with eyes, skin, and clothing. Empty containers retain product residue, liquid and/or vapour, it can be dangerous. Keep container tightly closed. Avoid contact with heat, sparks and flame. Avoid ingestion and inhalation. Do not pressurize, cut, weld, braze, solder, drill, grind, or expose empty containers to heat, sparks or open flames.

**Storage:** Container is under pressure. Keep away from heat, sparks, and flame. Keep away from sources of ignition. Store in a tightly closed container. Store in a cool, dry, well-ventilated area away from incompatible substances.
